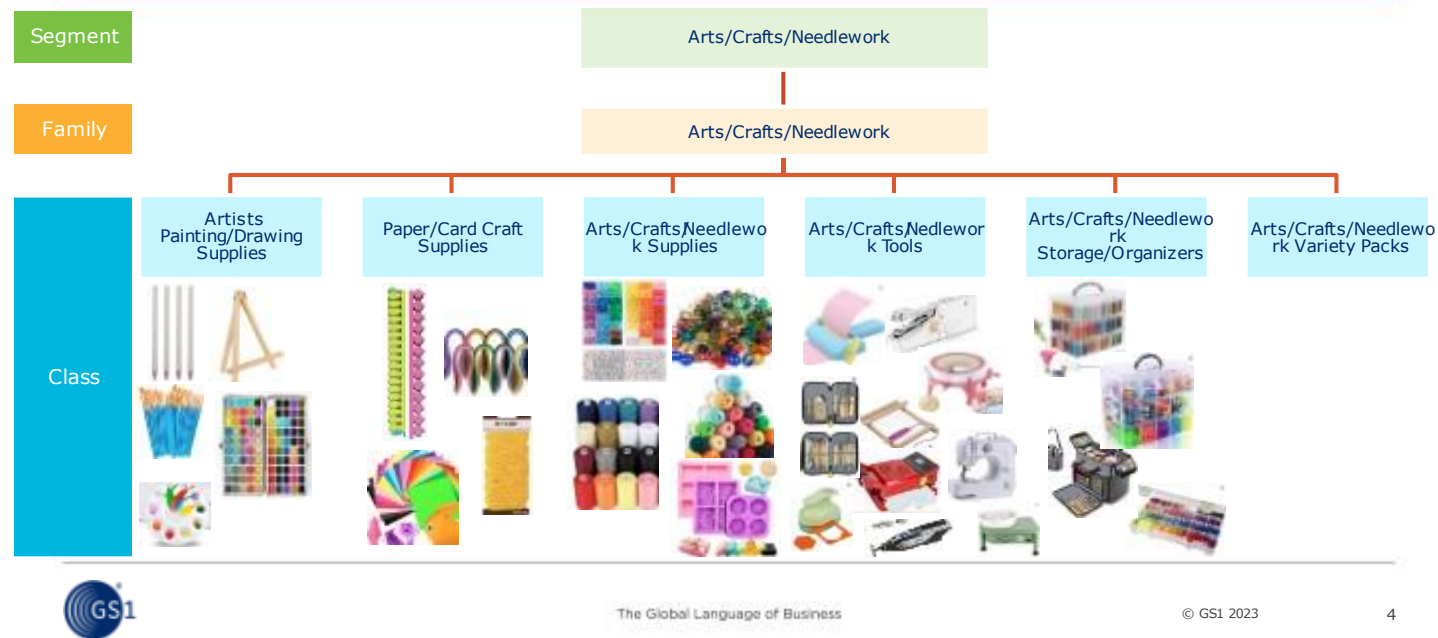

The following notable changes were made to support the November 2023 Publication.

Work Request 23-000071 – Arts/Crafts/Needlework - segment rearrangement

- This work request was submitted to have a more intuitive Schema based on what are the products and not their intended use.
- Total of 10 classes removed and 3 new classes created. 36 bricks removed, 30 bricks moved, and 6 bricks created.

Work Request 23-000123 – Adjustments to the class Oral Hygiene

- This work request was elaborated to update the oral hygiene class so that a brick effectively classifies a specific product category.
- Total of 13 new bricks created and 2 removed.

Work Request 23-000179 – Create different bricks for Solar Panels

- This Work request was submitted to have a new class for electrical generation to allow the classification of the different types of electrical generation.
- New class and 7 new bricks created.

Work Request 23-000180 – Create different bricks for Lighting

- This Work request was submitted to have a more intuitive Schema for lighting products.
- 5 New bricks created, 3 bricks removed~, and 6 bricks updated.

Work Request 23-000200 – Split segment Food/Beverage/Tobacco

- This Work request was submitted to split the current segment Food/Beverage/Tobacco into different segments, Food/Beverage and Tobacco/Cannabis.
- 1 New Segment, 1 Family and 7 Classes created. All the existing bricks related with Tobacco and Cannabis moved to this new structure.
