Figure 4-1 Parties and roles in the invoicing and payment processes

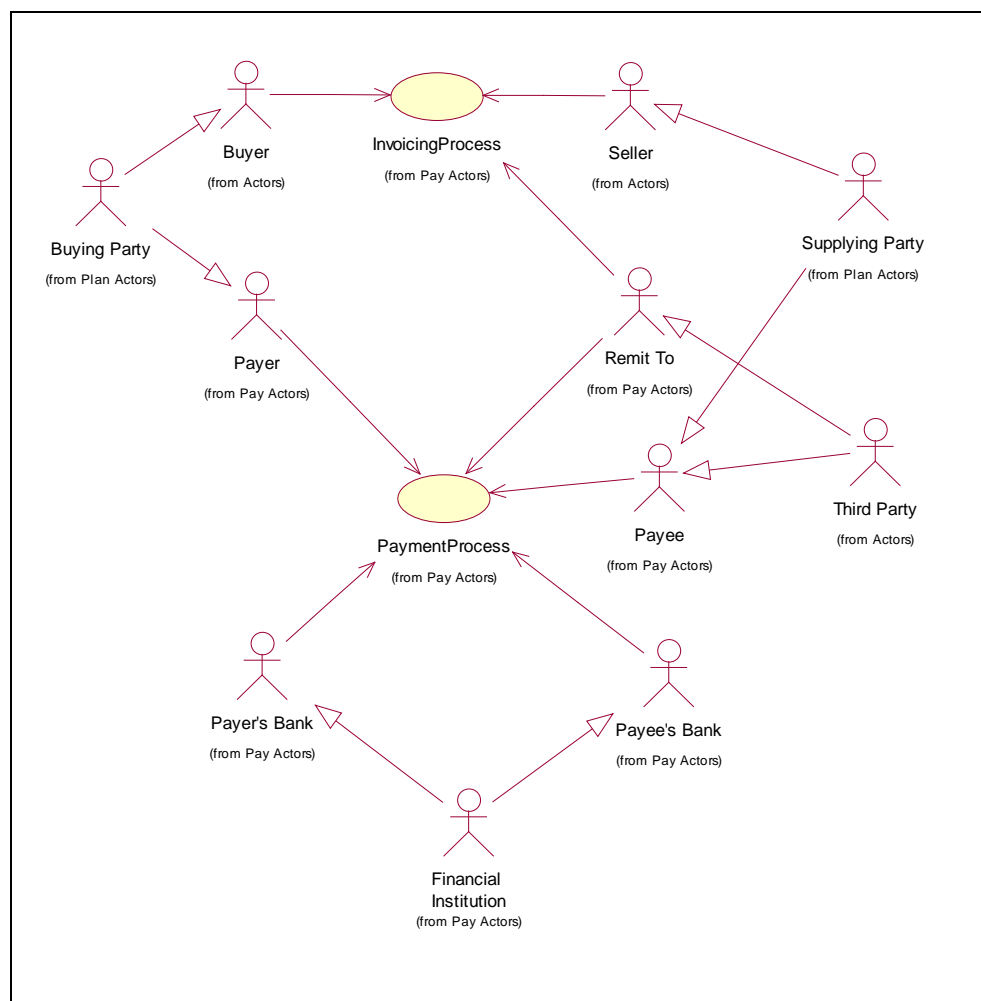
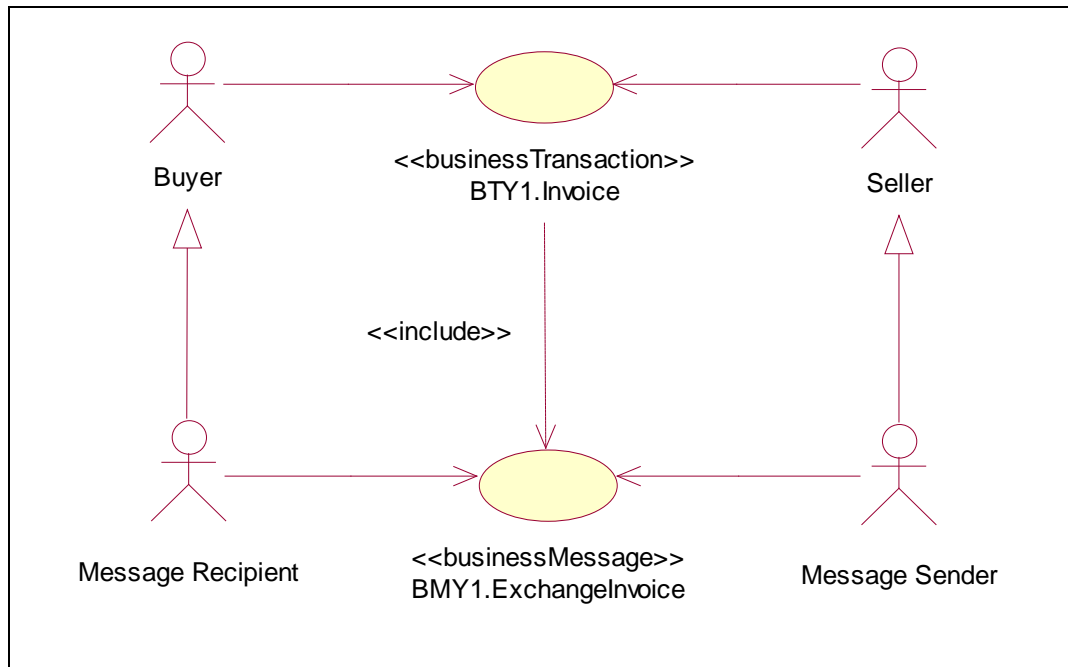


Figure 4-2 Use Case Diagram: Invoice Business Transaction
